<b>Clinics</b>	<p><b>Limited Co-Enrollment</b></p> <p>Clients in PROS programs that offer Clinical Treatment may choose to receive their clinical services either from the PROS or from another clinic provider.</p> <p>PROS providers who also have a clinic license cannot bill fee-for-service for their own PROS clients. These clients can only be billed for clinical treatment under the PROS.</p> <p>The Clinical Treatment component of PROS is reserved for PROS clients only.</p> <p>Clinic providers not under the corporate umbrella of the PROS agency may bill for clinic on a fee-for-service basis. Waivers for co-enrollment will be limited to those individual enrollees for whom the use of psychosocial club or intensive rehabilitation services could improve their potential for recovery. This approach will maintain the current opportunities available to ACT enrollees to participate in psychosocial clubs, vocational programs and use of IPRT services.</p> <p>ACT enrollees who have been granted a waiver will be allowed to concurrently enroll in PROS for a 3-month period.
